

Sentences cannot consist of treatment contrary to a sense of humanity and must aim at the re-education of the sentenced person.



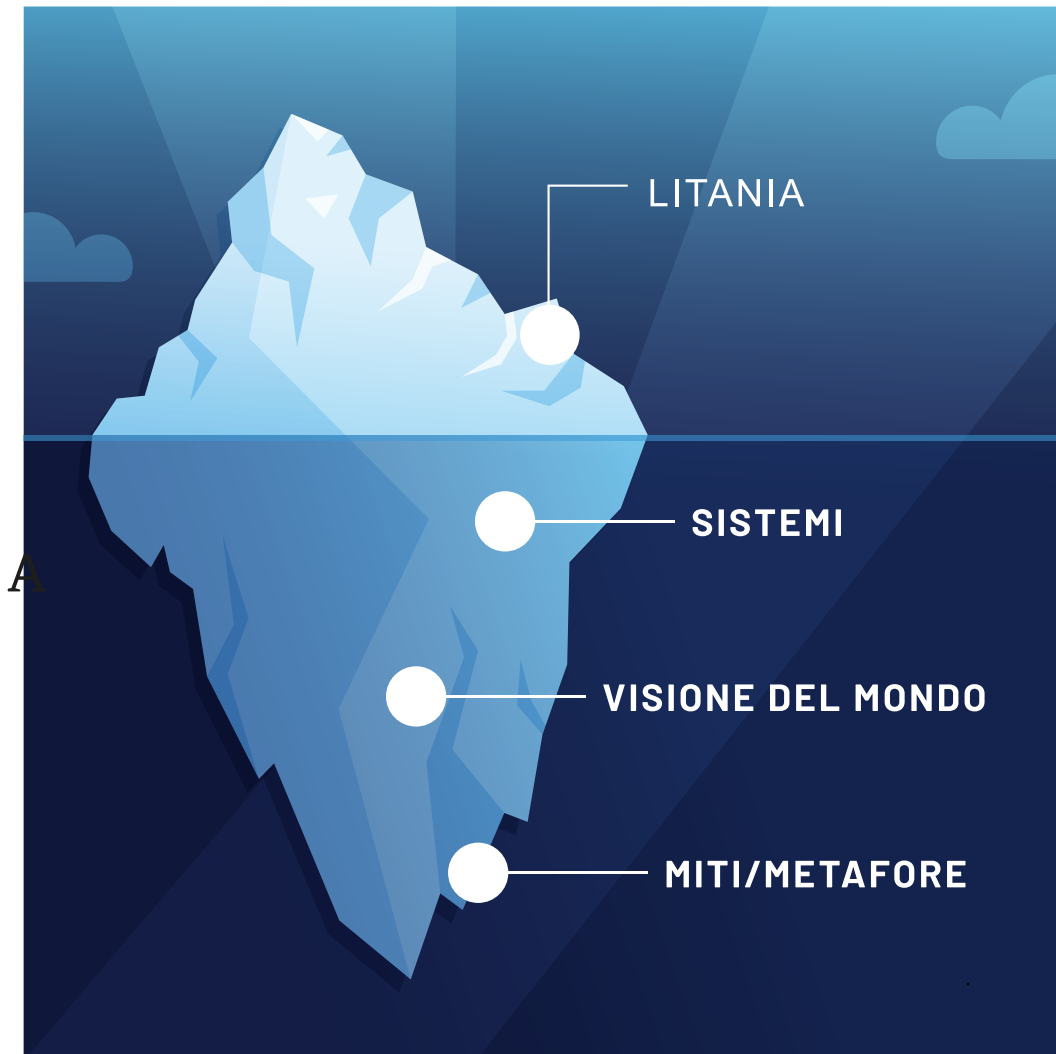

Anticipation in Public Futures as question of justice

- › (from Art. 27) “reeducation” of sentenced person as attempt to enable him/her to plan different futures

missing service

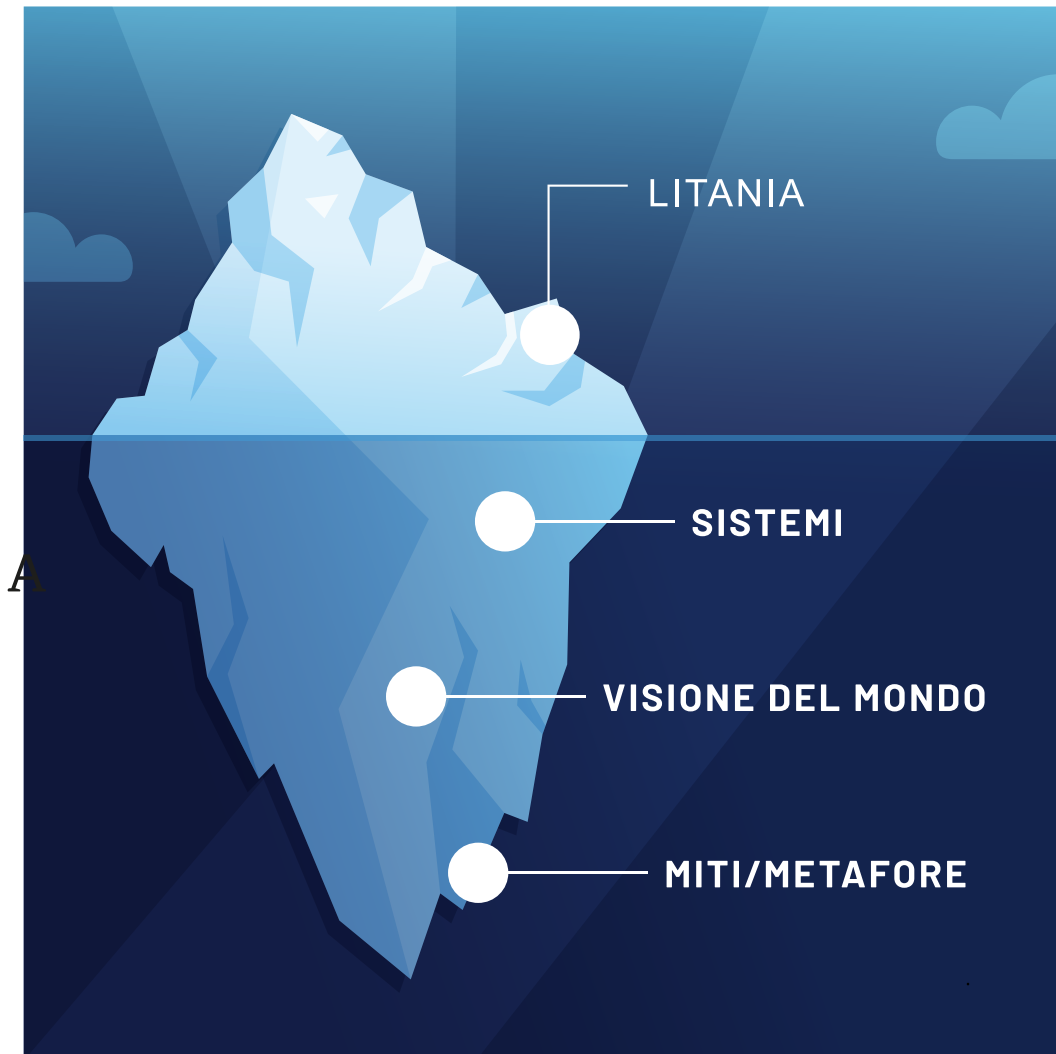
other priorities for public
